## **HLC 2017 Annual Conference**

The event, which was attended by representatives of the UMSL accreditation team, provided opportunities for participants to learn strategies, techniques, and "best-practices" from HLC executives, veterans of the peer review process, and individuals whose institutions have recently undergone reviews.

Attendance at this conference was critical to our reaccreditation efforts because the HLC review process has changed since our last institutional visit. When UMSL undergoes its reaccreditation visit on November 5-6, 2018, we will be reviewed under what is now called the "Open Pathway." When compared to the Standard and AQIP options, this pathway closely parallels the requirements of our successful reaccreditation effort from our last review.

At the conference, the reaccreditation team had the opportunity to devote a full day to sessions focusing on the criteria for accreditation in the Open Pathway, Federal Compliance, Quality Initiatives, Campus Engagement, Preparing Institutional Finances for Review, and workshops on resources and tools such as the HLC Assurance System. Reports from the leadership team and criterion co-chairs that attended the conference have been unanimously positive. Attendance at the conference paves the way for our success.
